- A. State of the School Report Highlights include:
  - As of October 18<sup>th</sup> 14% graduation rate
  - Due to Hurricane Ian, Pinellas MYcroSchool will need to make up 4 school days. Days have been added to the end of the school year.
  - Pinellas MYcroSchool was chosen by the District to be monitored for Title I
- **B.** Director of Community Relations and Student Recruitment Highlights include:
  - We have a signed lease for Northstar last night new location. AMIkids will be paying \$10,000 lease for November 2022.
  - We have other partners we are working with for the new building.

  - Old Location have been speaking to Pappas to separate from the lease. Option to sublease the location to Amped (next door; Amped taking the lead in lease negotiations. Will keep everyone posted.
  - Met with politicians regarding approval of blended learning for Pinellas MYcroSchool
  - Midtown Rotary donated \$1,000 to Pinellas MYcroSchool for new location Open House.
  - We have submitted request to White Foundation to help support move to new location.
  - We are receiving donated books and clothes for our school.
  - We are looking at ways to bring private sponsorship to Pinellas MYcroSchool.
  - New board members in the next coming months.
